Shaun Adams made a motion to appoint Ann Phillips with San Ran Hotel to the Robbinsville Tourism Authority board. Debbie Beasley seconded the motion. Shaun Adams made a motion to excluded Brian Johnson from voting since he is an employee of the Robbinsville Tourism Authority. Debbie Beasley seconded the motion. Both motions passed.

Brian Johnson made a motion to go into closed session based on GS143-318.11(c), (a)3. Shaun Adams seconded the motion. Vote unanimous.

The Board came out of closed session and Brian Johnson made a motion to send a letter to all customers that have been called in the past few months before their water is disconnected stating that there will be no more phone calls made before disconnection. There will also be a notice put on the Town office door to notify all customers that there will be no more phone calls prior to disconnection on two month pass due water bills. Debbie Beasley seconded the motion. Vote unanimous.
